WINNER

SeniorLink™ - *Caregiver Homes, Inc. (CGH) - Massachusetts*
SeniorLink™ is a cost effective, community-based program for elders with disabilities. CGH brings together all of the medical and social services needed by elders with levels of disability that qualify them for nursing home care and then places them with a caregiver in a private home.

RUNNERS-UP

"YourChoice" Health Plan - *The Center for Health and Lifestyle Management - Florida*
Manatee County's Center for Health and Lifestyle Management provides "people to people" educational services to its employees so they can make accountable health and lifestyle choices.

Occupational Health Services Project (OHS) - *Department of Labor and Industries - Washington*
The OHS Project in Olympia, WA improves injured worker outcomes and reduces disability through a community-based change in healthcare delivery.

Statewide Surgical Collaborative - *QCMetrix, Inc. - Massachusetts*
Waltham's QCMetrix proposes reducing surgical complications through the formation of a 35 hospital, payer-funded collaborative focused on surgical quality and a sustainable, cost-efficient system for tracking processes and outcomes.

Retail Clinics - *Carnegie Mellon University - Pennsylvania*
Through innovation in primary care, and geographic and financial accessibility, retail clinics provide a market-driven approach to cost containment for a broad set of clients.

SPECIAL RECOGNITION

Wellness Health Incentive Payments (WHIP) - *Maricopa County - Arizona*
The WHIP program improves overall service and access to quality medical services by holding healthcare benefit vendors accountable to nationally recognized performance measures.

Medicaid Savings and Improvements - *Center for Long-Term Care Financing - Washington*
Seattle's Center for Long-Term Care Financing proposes incentives to cut Medicaid spending by discerning eligibility and focusing preventative care on those who heavily depend on Medicaid for long-term care due to low income or need for care.

Health Insurance Cost Control - *Fallon Community Health Plan - Massachusetts*
Fallon's group health insurance plan saves money through a limited network of providers and a defined contribution strategy.

CPOE Initiative - *NEHI and MTC - Massachusetts*
The New England Healthcare Institute (NEHI) and Massachusetts Technology Collaborative's (MTC) Computerized Physician Order Entry (CPOE) gathers diagnostic and therapeutic orders for tests and drugs for patients to reduce errors and save money.
